## 103-3 COUNTRY'S "MAREN MORRIS AT BROOKLYN BOWL" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF-FM ("Station"), owned and operated by Cumulus Radio LLC located at, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 103-3 Country's "Maren Morris at Brooklyn Bowl" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Limit one (1) entry per person per **Instagram account.** Multiple participants are not permitted to share the same Instagram account. Any attempt by any participant to submit more than one (1) entry by using multiple/different Instagram accounts, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. Instagram entries will be deemed made by the authorized account holder of the Instagram account used to submit the entry at the time of entry. The authorized account holder is the natural person who is assigned to the Instagram account by Instagram. Entries submitted will not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by Show. Potential winner may be required to show proof of being the authorized account holder of the Instagram account. - 4. **Winner Selection.** On or about 10:00am CT on December 3, 2020, Station will select four (4) entries for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
