103-3 COUNTRY'S "FREE MUSIC FRIDAY – LUKE COMBS "WHAT YOU SEE AIN'T ALWAYS WHAT YOU GET" ALBUM" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF ("Station"), owned and operated by Cumulus Radio LLC located at, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 103-3 Country's "Free Music Friday – Luke Combs "What You See Ain't Always What You Get" Album" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest.
