## 95.5 NASH ICON'S "JAMEY JOHNSON AT THE AMPHITHEATER AT HOP SPRINGS" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WSM-FM ("Station"), owned and operated by Cumulus Radio LLC located at, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 95.5 NASH ICON's "Jamey Johnson at the Amphitheater at Hop Springs" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
