103-3 COUNTRY'S "SANTA – THE EXPERIENCE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF ("Station"), owned and operated by Cumulus Radio LLC located at, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

- 4. **Winner Selection.** On or about 2:00pm CT on December 3, 2020, Station will select four (4) entries for the Grand Prize in a random drawing from among all valid entries received by the Station to that point. On or about 10:00am CT on December 10, 2020, Station will select four (4) entries for the Grand Prize in a random drawing from among all valid entries received by Station to that point. On or about 10:00am CT on December 10, 2020, Station will select four (4) entries for the Grand Prize in a random drawing from among all valid entries received by Station to that point. On or about 10:00am CT on December 14, 2020, Station will select eight (8) entries for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest.
