103-3 Country's "The Dancing Lights of Christmas Tickets" Contest Official Rules

A complete copy of these rules can be obtained at the offices of radio station WKDF ("Station"),owned and operated by Cumulus Radio LLC located at, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

On or about 10:00am CT on December 1, 2020, Station will select ten (10) entries for the Grand Prize in a random drawing from among all valid entries received by the Station to that point. On or about 10:00am CT on December 4, 2020, Station will select ten (10) entries for the Grand Prize in a random drawing from among all valid entries received by the Station to that point. On or about 10:00am CT on December 9, 2020, Station will select five (5) entries for the Grand Prize in a random drawing from among all valid entries received by the Station to that point. On or about 10:00am CT on December 15, 2020, Station will select five (5) entries for the Grand Prize in a random drawing from among all valid entries received by the Station to that point. On or about 10:00am CT on December 18, 2020, Station will select five (5) entries for the Grand Prize in a random drawing from among all valid entries received by the Station to that point. On or about 10:00am CT on December 21, 2020, Station will select five (5) entries for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest.
