103-3 COUNTRY'S "WIN JASMINE'S DIAMOND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF ("Station"), owned and operated by Cumulus Radio LLC, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 103-3 Country's "Win Jasmine's Diamond" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. - 2. **Contest Period.** The Contest will begin at **7:01am CT on February 1, 2021** and will run through **4:59pm CT on February 12, 2021** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

When Station announces a Keyword, send a text message with the Keyword spelled correctly to 68683. Entries must be received at the end of the hour of each Contest Round in which they were announced (i.e. 7:59am CT, 12:59pm CT or 4:59pm CT) each day to be a valid entry. **Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number per hour/Keyword. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry per hour/Keyword by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.**
 - (ii) <u>Online</u>: Visit the Station's website <u>www.1033country.com</u> during the Contest Period, click on the "Contest" link, click on the "Win Jasmine's Diamond" Contest link, and complete an entry form including correctly typing in the Keyword. Entries must be received at the end of the hour of each Contest Round in which they were announced (i.e 7:59am CT, 12:59pm CT or 4:59pm CT) each day to be a valid entry. Limit one (1) entry per person per hour/Keyword, regardless of how many email addresses a person may possess and use. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per hour/Keyword by using multiple/different email addresses, identities, registrations and logins, or any other methods will

void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

Texting in will not increase your chances of winning.

Listeners may either (i) text in an entry into a particular Contest Round using a mobile device or (ii) enter online, but not both methods. Limit one (1) entry per person/telephone number/email address per Contest Round, regardless of the method of entry chosen by a listener.

- 4. **Winner Selection.** Each weekday during the Contest Period, on or about 8:15am CT, 1:15pm CT and 5:59pm CT, Station will select one (1) entry to win a Qualifying Prize (as defined below) and be entered to win the Grand Prize (as defined below) (each a "Qualifier") in a random drawing from among all valid entries received by Station during the Contest Round that immediately preceded the drawing. On or about 6:30pm CT on February 12, 2021, Station will select one (1) entry for the Grand Prize in a random drawing from among all Qualifiers. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within thirty (30) days of winning will result in disqualification and forfeiture of the prize.

IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
