## 103-3 COUNTRY WKDF'S "PICKIN' PARTY WITH KIP MOORE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF ("Station"), owned and operated by Cumulus Radio LLC, 10 Music Circle East, Nashville, TN 37203, by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 103-3 Country's "Pickin' Party with Kip Moore" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
  - Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio. Void where prohibited by law. Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.
