103-3 COUNTRY WKDF'S "PICKIN' PARTY WITH LINDSAY ELL" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKDF ("Station"), owned and operated by Cumulus Radio LLC, 10 Music Circle East, Nashville, TN 37203, by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 103-3 Country's "Pickin' Party with Lindsay Ell" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text

message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
