103-3 COUNTRY'S "FREE MUSIC FRIDAY – GABBY BARRETT" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WKDF ("Station"), owned and operated by Cumulus Radio LLC located at, 10 Music Circle East, Nashville, TN 37203, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the 103-3 Country's "Free Music Friday – Gabby Barrett" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

Texting in will not increase your chances of winning.

Listeners may either (i) text in an entry using a mobile device or (ii) enter online, but not both methods. Limit one (1) entry per person/telephone number/email address, regardless of the method of entry chosen by a listener.

- Winner Selection. On or about 2:00pm CT on March 18, 2021, Station will select two (2) entries for a Prize in a random drawing from among all valid entries received by the Station from both entry methods during the Contest Period as of the date and time of that drawing. On or about 10:00am CT on March 22, 2021, Station will select two (2) entries for a Prize in a random drawing from among all valid entries received by Station from both entry methods during the Contest Period. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).
