## 95.5 NASH ICON'S "GARTH BROOKS TICKETS" CONTEST OFFICIAL RULES

Listen to the Station on Monday from 6:01am CT to 10:59am CT, Tuesday from 2:00pm CT to 6:59pm CT, Wednesday from 10:00am CT to 1:59pm CT, Thursday from 1:00pm CT to 4:59pm CT and Friday from 7:00am CT to 10:59am CT during the Contest Period (each a "Selection Day"). When the Station plays two (2) Garth Brooks songs back to back in their entirety, listeners should call the Station at 615-737-9500. Caller seven (7) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal.
