WKDF-FM'S "PROFESSIONAL BULL RIDERS: STAMPEDE DAYS 2022 AT BRIDGESTONE ARENA ONLINE REGISTER-TO-WIN" CONTEST OFFICIAL RULES

The Station will conduct the **WKDF-FM's "PROFESSIONAL BULL RIDERS: STAMPEDE DAYS 2022** AT **BRIDGESTONE ARENA ONLINE REGISTER-TO-WIN"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
