103-3 COUNTRY'S "WINNING WEEKEND – SALUTE TO VETERANS CONCERT" CONTEST OFFICIAL RULES

1. A complete copy of these rules can be obtained by contacting radio station WKDF ("Station"), 10 Music Circle East, Nashville, TN 37203, during available business hours Monday through Friday, on the Station website <u>www.1033country.com</u>, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **103-3 COUNTRY'S "WINNING WEEKEND** – **SALUTE TO VETERANS CONCERT"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

2. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59 PM CT on November 6, 2022 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. [IF TRUE: Limit one (1) entry per person per phone number.]
- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
