## 103-3 Country's "WINNING WEEKEND – 103.3 COUNTRY CONCERT SERIES: MATT Stell and George Birge" Contest Official Rules

2) NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 5) Verification of Potential Winner.
