103-3 COUNTRY'S "TICKETS FROM 103.3 IN 2023 WEEK – WEEK OF 7/3/2023" CONTEST OFFICIAL RULES

The Station will conduct the **103-3 COUNTRY'S "TICKETS FROM 103.3 IN 2023 WEEK – WEEK OF 7/3/2023"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

2. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the last **30 days**, and whose immediate family members or household members have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the last 30 days. Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. 3. Contest Period. The Contest entry period will begin at 12:00 AM CT on Monday, July 3, 2023, and will run through 11:59 PM CT on Friday, July 7, 2023 (the "Contest Period"). The Station's computer is the official time-keeping device for this Contest.

4. **How to Enter.**

On-Air: Listen to the Station weekdays during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners must call the Station at (615) 737-1033. Caller number seven (7) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE

The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize.
