103-3 COUNTRY'S "WINNING WEEKEND – OUTLAW MUSIC FESTIVAL" CONTEST OFFICIAL RULES

The Station will conduct the **103-3 COUNTRY'S "WINNING WEEKEND** – **OUTLAW MUSIC FESTIVAL"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

2) NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. - 5) Verification of Potential Winner.
