103.3 COUNTRY "NASHVILLE SC V. PHILADELPHIA WINNING WEEKEND" CONTEST OFFICIAL RULES

One (1) different keyword will be announced each hour during the Contest Period from 10:00am to 7:00pm CT on Saturday and 6:00am to 7:00am and 10:00am to 3:00pm CT on Sunday for a total of six (6) different keywords throughout the Contest Period. **Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant.
